ARTICLES OF INCORPORATION

OF

NOVELLO ENTERPRISES, INC.

The undersigned, a natural person competent to contract, acting as incorporator of a comporation (hereinafter referred to as the "Corporation") under the provisions of the State of Florida, 1-2-0 adopts the following Articles of Incorporation:

ARTICLE 1.

1.1) Name: The name of the corporation is Novello Enterprises, Inc.

ARTICLE 2. Nature of Business

2.1) <u>Nature of Business.</u> The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE 3. Capital Stock

- 3.1) Number of Authorized Shares. The aggregate number of shares which the Corporation shall have authority to issue is 1,000 shares of Common Stock, having a par value of \$1.00 per share.
- 3.2) Right and Method of Voting. At every meeting of the stockholders, every holder of the Common Stock of the Corporation shall be entitled to one (1) vote for each share of Common Stock standing in his/her/its name on the books of the Corporation. At each election for Directors, every holder of the Common Stock of the Corporation shall have the right to vote, in person or by proxy, the number of shares owned by his/her/its for as many persons as there are Directors to be elected and for whose election he/she/it has a right to vote, or to cumulate his/her/its votes by giving one

candidate as many votes as the number of such Directors multiplied by the number of his/her/its shares shall equal, or by distributing such votes on the same principal among any number of such candidates.

- 3.3) Payment for Shares. The consideration for the issuance of the Common Stock of the Corporation may be paid, in whole or in part, in money or other property, tangible or intangible, or in labor or services actually performed for the Corporation. When payment for the consideration for which such shares are to be issued shall have been received by the Corporation, such shares shall be deemed to be fully paid and non-assessable. Neither promissory notes nor future services shall constitute payment or part-payment for such shares of the Corporation. In the absence of fraud in the transaction, the judgment of the Board of Directors or the stockholders, as the case may be, as to the value of the consideration received for such shares shall be conclusive.
- 3.4) <u>Dividends</u>. The holders from time to time of the Common Stock of the Corporation shall be entitled to receive, when and as declared by the Board of Directors, from the net earnings or from the surplus of the assets over the liabilities, including capital, of the Corporation, but not otherwise, dividends payable either in cash, in property, or in shares of the Common Stock of the Corporation.

ARTICLE 4. Period of Duration

4.1) Period of Duration. The period of duration of the Corporation is perpetual.

ARTICLE 5. Registered Agent and Address

5.1) Address. The initial business address of the Corporation in the State of Florida is 7914

Royal Birkdale Circle, Bradenton, Florida 34202. The Board of Directors may, from time to
time, move the principal office to any other address in Florida, upon giving notice, if required, to the

Florida Secretary of State.

5.2) Registered Agent. The Registered Agent of the Corporation shall be Dr. Michael A. Novello, whose business office is at 7914 Royal Birkdale Circle, Bradenton, Florida 34202.

ARTICLE 6. Data Respecting Directors

- 6.1) Initial Board of Directors. The initial Board of Directors shall consist of Two (2) members. The initial Board of Directors shall hold the organizational meeting of the Corporation.
- 6.2) Names and Addresses. The name and address of the initial members to the Board of Directors, who shall serve until the first annual meeting of stockholders or until successors shall have been elected and qualified is:
