ARTICLE IX. INCORPORATOR

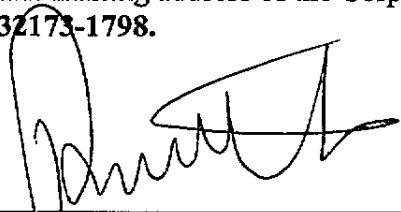

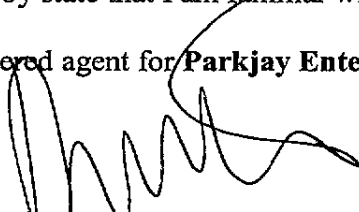
