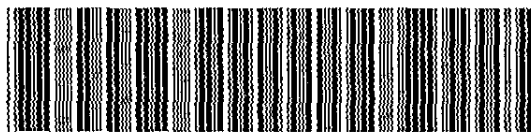

1. Article I NAME is amended to change the name of the Corporation to:

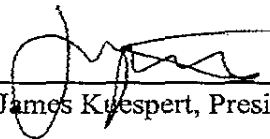
