We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the General Corporation Law, Chapter 607, Florida Statutes, 1985.

ARTICLE I.

The name of this corporation shall be **HOMES TO RANCHES MAINTENANCE, INC**, and its corporate address shall be; 5475 NW 75th Ave., Ocala, Florida 34482.

ARTICLE II.

General Nature of Business

The general nature of the business to be transacted by the corporation shall be:
