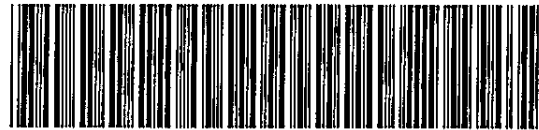

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

1. The name of the corporation is

2. The general purpose or purposes for which the corporation is initially organized is catalog and internet sales of solar energy products, and to transact any and all business allowed by law in the State of Florida.

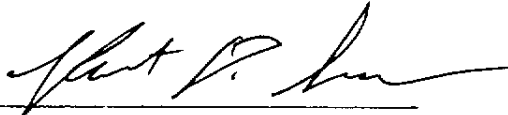

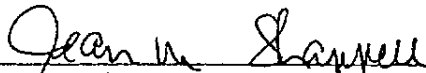
