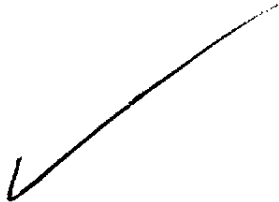

ARTICLE I - CORPORATE NAME

The name of the Corporation is: VILLAGE PRODUCTIONS, INC..

ARTICLE II - NATURE OF BUSINESS AND POWERS

The principal nature of the business to be transacted by this corporation is to engage any business permitted under the Laws of the state of Florida, and specifically produce films, advertisement, documentaries, and any other product involved in the film industry.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is (100) shares of common stock having per value of (\$1.00) per share.

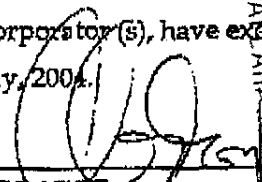

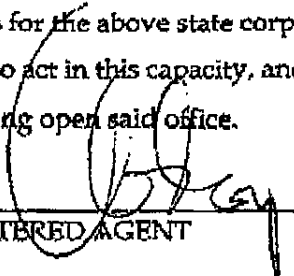
