

ARTICLES OF INCORPORATION

OF

AUTOMATED SOFTWARE TOOLS CORPORATION

The undersigned, Donald S. Higgins, subscriber to these Articles of Incorporation, being a natural person over the age of eighteen (18) years of age, competent to contract, hereby presents these Articles for the formation of a Corporation under the laws of the State of Florida.
