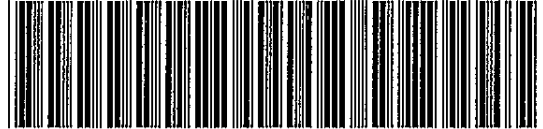



The undersigned hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be JCL Ventures Corp. The address of the principal office of this corporation shall be 169 E. Flagler Street, Suite 1600, Miami, FL 33131, and the mailing address of the corporation shall be the same.
