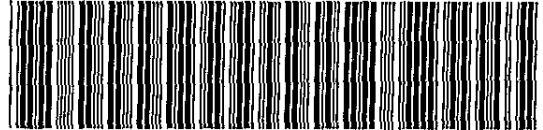

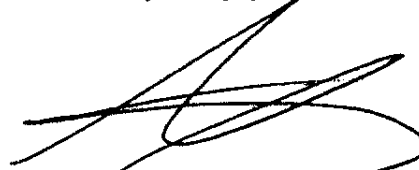

ARTICLES OF INCORPORATION
of

ARTICLE I
NAME

The name of the corporation is REBECCA T. FAIRCLOTH, P.A.

ARTICLE II
DURATION

The period of duration of the corporation is perpetual.

ARTICLE III
PURPOSE

RENDITION OF PROFESSIONAL SERVICES

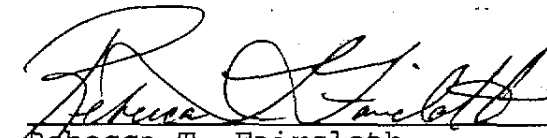

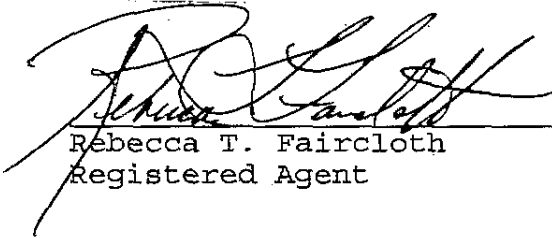
