

## ARTICLES OF INCORPORATION of REBECCA T. FAIRCLOTH, P. A.

#### ARTICLE I

The name of the corporation is REBECCA T. FAIRCLOTH, P.A.

## ARTICLE II DURATION

The period of duration of the corporation is perpetual

## ARTICLE III PURPOSE

The purpose is to engage in the transaction of real estate as an associate of a licensed real estate broker.

#### ARTICLE IV PRINCIPAL OFFICE AND MAILING ADDRESS
