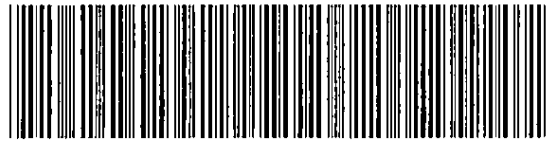

**2) Addition of Article to Articles of Incorporation**

If permitted by state law, any named officer and/or director may continue to manage the business affairs of the corporation upon the death of Dr. Dorothy Blank. Management of business affairs refers solely to financial and management decisions and processes including but not limited to the procurement of a medical practitioner to continue the business while a purchaser is found, procurement of a valid health care clinic license, payment of debts, collection of accounts receivable, access to, and full use of business funds for all purposes including to make necessary repairs or otherwise modernize the practice to procure a better sales price for the practice, engage with insurance companies to enforce rights to collect patient fees, and sell the practice. The officer and/or director will be entitled to compensation for these services.

If permitted by state law at the time of Dr. Dorothy Blank's death, Article III of the Articles of Incorporation's prohibition against the transfer of shares to any person who is not a physician shall be null and void. Susan T. Lascale, should she survive the medical doctor by 1 day, shall receive Dr. Dorothy Blank's 100% ownership shares whether or not these exist in certificate form, by means of this transfer-on-death

designation. If the transfer of shares to Susan T. Lascale is not permitted by state law, then ownership of Dr. Dorothy Blank's entire interest in Ankle & Foot Centre of South Florida shall pass by means of this transfer-on-death provision, to the Dorothy Blank Revocable Trust or if such trust is not in existence at the time of the Doctor's passing, ownership shall pass to the doctor's estate, Estate of Dorothy Blank.

All other terms of the Articles of Incorporation of Ankle & foot Centre of South Florida, P.A. are hereby restated.

**This amendment was adopted by the shareholders on June 27, 2023. The number of votes cast for the amendment by the shareholders was sufficient for approval.**
