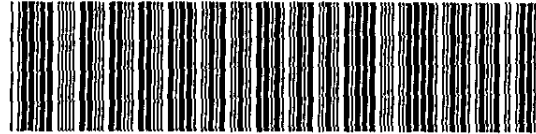

The name of this corporation is Jeff Frankel Consulting, Inc.
