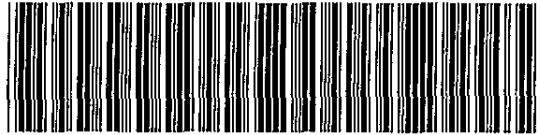

ARTICLE I - NAME

ARTICLE III - PURPOSE

This corporation is organized for the purpose of rendering specific professional service as Real Estate Sales Associate.
