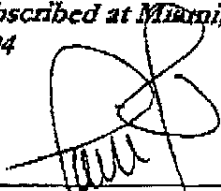
ARTICLE IX

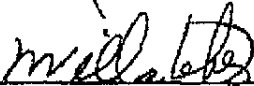

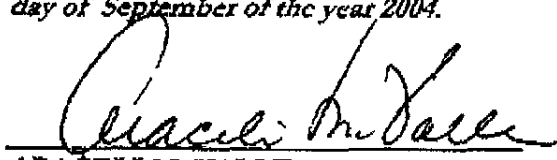

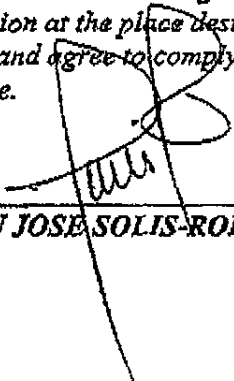
