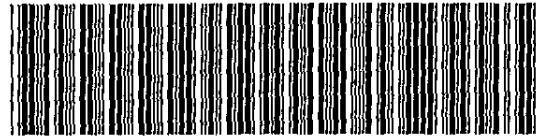

ARTICLES OF INCORPORATION

ARTICLE I. NAME

The name of this corporation is
CARRIE'S FENCE OF PALM BAY, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

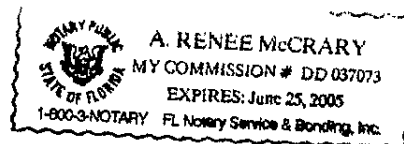
