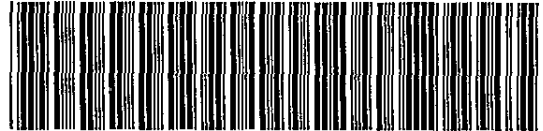

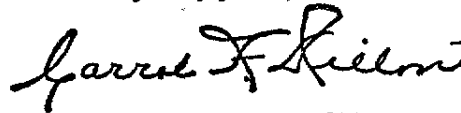

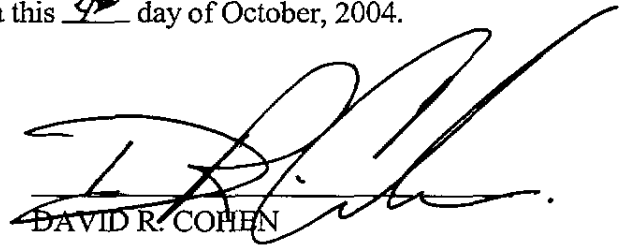
ARTICLE IX

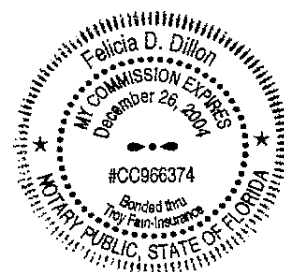

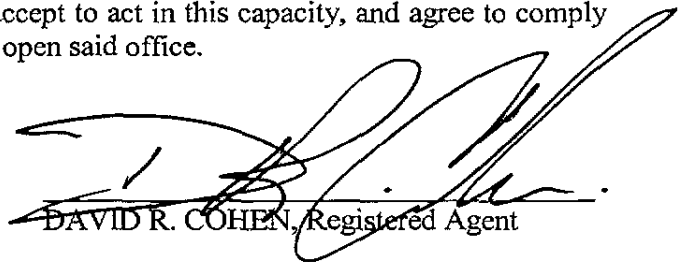
