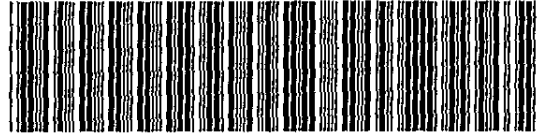

**ARTICLES OF INCORPORATION

ARTICLE I: NAME AND PRINCIPAL OFFICE ADDRESS

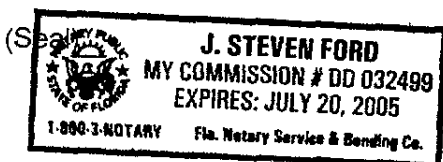
