# Articles of Incorporation Of CENTRAL FLORIDA DENTAL GROUP, INC.

#### **ARTICLE I**

### Name and Duration

The name of the Corporation shall be CENTRAL FLORIDA DENTAL GROUP, INC.

The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

# ARTICLE II

#### **Principal Office**

#### ARTICLE III

# Registered Office and Agent

#### **ARTICLE IV**

#### Corporate Purposes, Powers and Rights

1. The nature of the business is a professional association to provide professional dental care to the public. The purposes of the Corporation are to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.
