### ARTICLES OF INCORPORATION P.L.L., BY AMOR, INC.

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

#### ARTICLE ONE NAME

The corporate name shall be: P.L.L., BY AMOR, INC.

#### ARTICLE TWO CORPORATE DURATION

The duration of the corporation is perpetual.

#### ARTICLE THREE **PURPOSE OR PURPOSES**

The general purposes for which the corporation is organized are:

  - 2. To engage in the hair styling, and beauty business.

- To engage in any activities or businesses permitted under the laws of the United States and the State of Florida.
- To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

## ARTICLE FOUR CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is 100 shares. Such shares shall be of a single class, and shall have \$1.00 par value.
