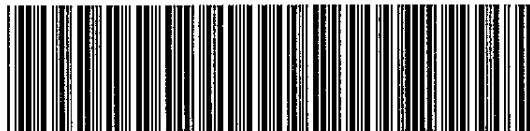

Article I
Name

The name of this corporation is ANTIQUÉ ITALIA IMPORT, INC.

Article II
Principal Office Address

Article III
Nature of Business

This Corporation is being formed for the following purposes:

- a. To engage in any and all lawful business or activity permitted under the laws of the United States and the State of Florida.

- c. 
