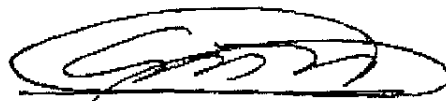
ARTICLE IX-AMENDMENTS.

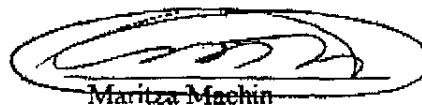
