**ARTICLES OF INCORPORATION
OF

The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

ARTICLE I
Name

The name of the Corporation shall be 407 HOME IMPROVEMENT CORP.

ARTICLE II
Principal Office

ARTICLE III
Corporate Purposes, Power and Rights


