ARTICLES OF INCORPORATION

OF

TRICIA C. JENKINS, P.A.

a Florida Corporation

The undersigned natural person, who is duly licensed to practice the profession of law in the State of Florida, desires to form a professional corporation pursuant to Chapters 621 and 607 of the Florida Statutes, for the purpose of rendering legal services and hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - CORPORATE NAME

The name of the Corporation is Tricia C. Jenkins, P. A.

ARTICLE II - PURPOSE AND POWERS

The purpose of the Corporation is to engage in the general practice of law.

The Corporation shall have the power to invest its funds in real estate, mortgages, stocks, bonds, or any other types of investment.
