

ARTICLES OF INCORPORATION

OF

KINGSTONE COMICS, INC.

ARTICLE ONE

The name of this corporation is: KINGSTONE COMICS, INC.



ARTICLE TWO

The principal place of business and mailing address of the company is:

ARTICLE THREE

The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under the Florida Corporations Code other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the Florida Corporations Code.

ARTICLE FOUR

This corporation is authorized to issue two (2) classes of shares of stock which shall be designated Preferred Stock and Common Stock. The total number of shares of Preferred Stock authorized to be issued is ten million (10,000,000) shares with a par value of one dollar (\$1.00) per share and the total number of shares of Common Stock authorized to be issued is twenty million (20,000,000) shares with a par value of one tenth of a mil (\$0.0001) per share.

The Board of Directors, within the limits and restrictions stated in any previously adopted resolution or resolutions of the Board of Directors originally fixing the number of shares constituting a series, may increase or decrease the number of shares of any series subsequent to the issuance of shares of that series provided

that any such decrease does not reduce the number of shares of any series below the number of shares of that series then outstanding.
