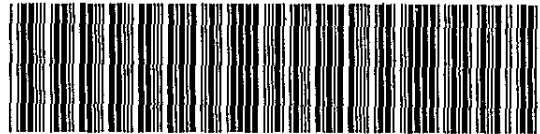

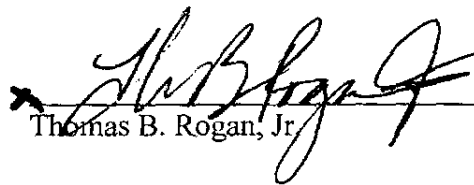

ARTICLE X: AMENDMENT

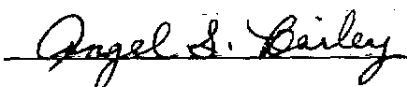

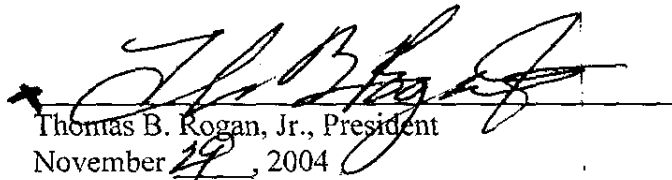

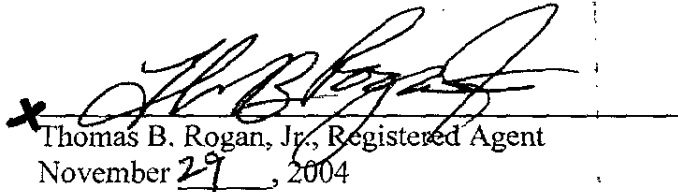
