ARTICLES OF INCORPORATION OF DOLAN ENTERPRISES OF SOUTHWEST FLORIDA, INC.

The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, hereinafter referred to as the Corporation,

ARTICLE I - NAME AND PRINCIPAL OFFICE

The name of the Corporation shall be Dolan Enterprises of Southwest Florida, Inc., a Florida corporation. The street address of the initial principal office of the Corporation and the mailing address of the Corporation is 404 21st Place, Bradenton Beach, FL 34217.

ARTICLE II - PURPOSE AND POWERS

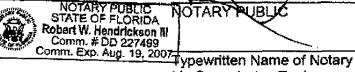
