**ARTICLES OF INCORPORATION
OF

The undersigned Incorporator, for the purpose of forming a Corporation for profit under the

Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this Corporation is: **SGRO SOUTH, INC.**

ARTICLE VIII - AMENDMENT




