ARTICLES OF INCORPORATION OF SLK ENTERPRISES, INC.

The undersigned Incorporators hereby file these Articles of Incorporation in order to form a Corporation under the laws of the State of Florida, effective January 1, 2005.

Article 1. Name and Principal Office

The name of this Corporation shall be SLK Enterprises, Inc. The principal place of business and mailing address of this Corporation shall be 227 South Calhoun Street, Tallahassee, Florida 32302-0391.

Article 2. Nature of Business

The Corporation may engage in any activity or business permitted under the laws of the United States of America and the State of Florida.

Article 3. Stock

The authorized capital stock of this Corporation shall consist of one thousand (1,000) shares of voting common stock with a par value of one cent (\$0.01) per share. The stock of the Corporation shall be issued for such consideration as may be determined by the Board of Directors, but not less than par value.
