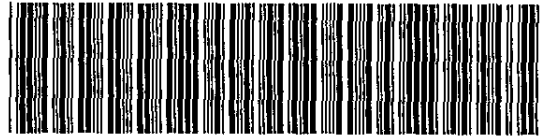

ARTICLE I - NAME

The name of this corporation is: DAVIE TRAVEL CENTER, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The Corporation's business and purpose shall consist solely of the following:

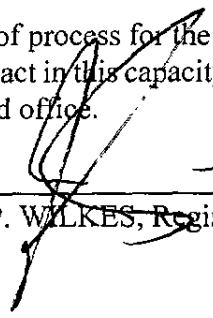
