CAPITALIZATION





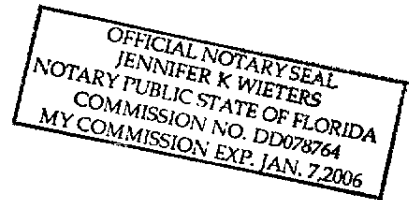
