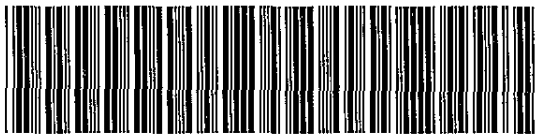

**THIRD:** The date of the adoption of this amendment is the 14 October 2005.

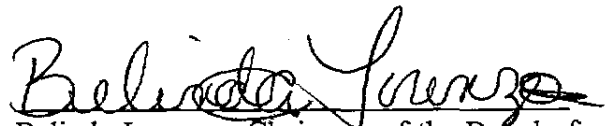
