I, the undersigned, hereby associate myself for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida.

ARTICLE I
CORPORATE NAME

ARTICLE II
GENERAL NATURE OF BUSINESS

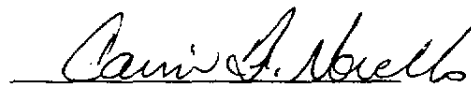

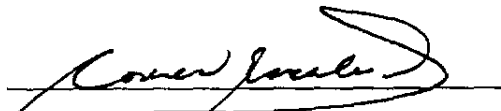
