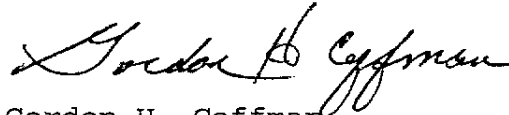

The undersigned, who is duly licensed to practice law in the State of Florida, for the purpose of forming a professional corporation under the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation shall be

LAW OFFICE OF MARK SALAMEH, P.A.

ARTICLE II

PURPOSE

The sole and specific purpose for which this corporation is organized shall be the rendering professional legal services, and to do all those things that are necessary or proper in connection with the practice of law in the State of Florida.

ARTICLE III

PROFESSIONAL SERVICES

The professional services of the corporation shall be rendered only through officers, employees and agents who are duly licensed or otherwise legally authorized to practice law within the State of Florida. Professional services shall be rendered in each case by the officer, employee or agent designated solely by the corporation, acting through its duly elected officers, and no officer, employee or agent shall enter into any contract, written or verbal, for professional services with any client wherein the right to select the person by which the services shall be rendered is delegated to the client. This provision shall not be applicable to the extent that it is in conflict with law or the professional rules pertaining to the practice of law in the State of Florida.

ARTICLE IV

AUTHORIZED SHARES

The aggregate number of shares which the corporation has authority to issue is ONE THOUSAND (1,000), all of which shall be common shares with par value of One Dollar (\$1.00).

ARTICLE V

INITIAL REGISTERED OFFICE

The street address of the initial registered office of the corporation is 5334 Chiquita Boulevard South, Suite 204, Cape Coral, Florida 33914, and the initial registered agent at such address is AMER SALAMEH.

ARTICLE VI

DIRECTORS

5.1 The business of the corporation shall be managed by its Board of Directors. The number of Directors constituting the entire Board may be increased or decreased from time to time by amendment of the Bylaws in a manner not prohibited by law. The Board shall consist of one director initially.

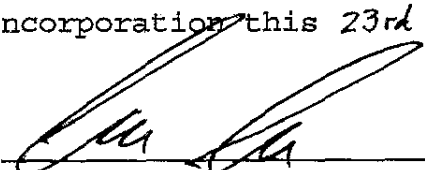

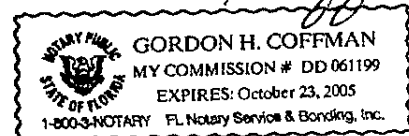
