#### ARTICLE VIII - BYLAWS

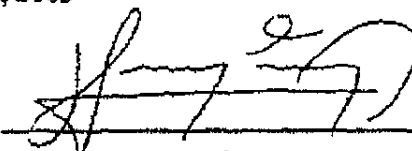
