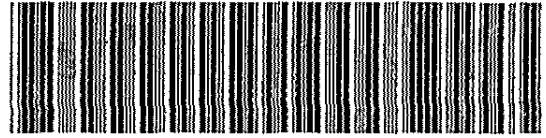



THE UNDERSIGNED, FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE FLORIDA GENERAL CORPORATION ACT, HEREBY ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION:

**ARTICLE I. NAME**

THE NAME OF THIS CORPORATION IS **MILLMAN ENTERPRISES, INC.**

**ARTICLE II. PRINCIPAL PLACE OF BUSINESS**

**ARTICLE VII. REGISTERED AGENT AND OFFICE**
