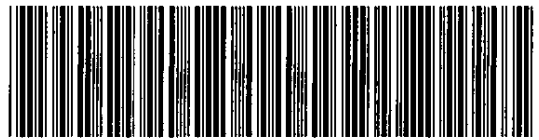



We are in receipt of your letter dated January 6, 2010. We recognize your denial of the above-referenced name due to the lack of descriptive distinction sufficient to avoid the implication that the nature of our business is not involved in a bank or bank holding company.

Since the company is a non-banking company we are in agreement that we need to add other verbiage to the official name to distinguish the type of business being conducted. Therefore we intend to comply by changing the official company name upon acceptance of our request for approval of our new name. Upon receiving a no objection letter from the Office of Financial Regulation we intend to amend and change the corporate and official company name with the Commercial Recordings office with the Division of Corporations, Department of State.

We believe that by adding the words Financial Group to our original name we are disclosing that we are an intermediary or commercial finance company and not a commercial bank, bank holding company, direct bank, savings and loan or a credit union. We are not involved in any store front retail operations; we are considered a commercial finance company.

Thanking you in advance for your consideration and assistance in allowing us to better understand the reasons and importance. We look forward to be able to maintain our presence in Florida and commence operations in Florida after receipt of your No Objection Letter to our request for approval attached.

Reference is made to your recent request for approval of the use of the above-referenced name in the state of Florida.

The use of the words "bank," "banco," "banque," "banker," "banking," "trust company," "savings and loan association," "savings bank," "credit union," or words of similar import, by any person other than a bank or trust company, in any context or in any manner which indicates or reasonably implies that the business being conducted or advertised is that of a bank or trust company or holding company is prohibited by Section 655.922, Florida Statutes.

This Office has previously approved the use of the words "bank" or "trust company" by non-banking companies where they are used in connection with other words which serve to distinguish the type of business being conducted from that of a bank, trust company or holding company.

Since the above-referenced name does not provide any descriptive distinction sufficient to avoid the implication that the nature of the business is that of a banking corporation, domestic /international banking office, or credit union, we are unable to approve your request for use of the above-referenced name.

Should you wish to resubmit another name or change your choice of names to clearly indicate that your company is not a commercial bank, holding company, savings and loan, credit union, or subsidiary thereof, we will be glad to give it consideration.
