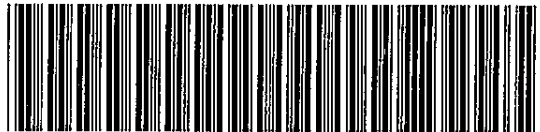

**Bylaws**


