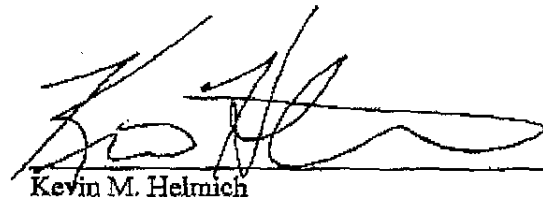
ARTICLE X
