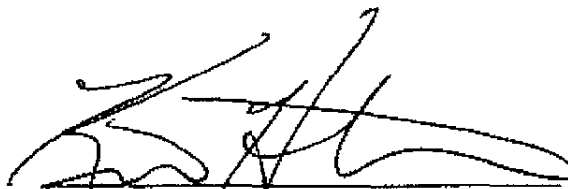
ARTICLE X

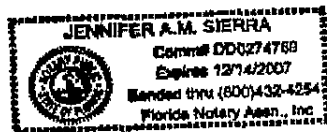

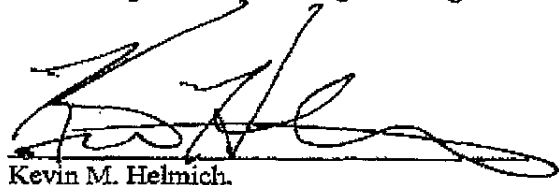

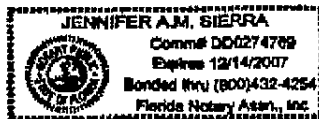
