ARTICLE I - NAME AND ADDRESS

The name of this corporation is **4-STAR POWER EQUIPMENT, INC.** The street address of its initial principal place of business is 3776 N. Access Road, Englewood, Florida 34225, and its mailing address is 99 Nesbit Street, Punta Gorda, Florida 33950.

ARTICLE II - DURATION

This corporation shall have perpetual existence or shall exist until dissolved by operation of law.




