# ARTICLES OF INCORPORATION OF BRICK INVESTMENT PROPERTIES CORP.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

# ARTICLE I - Name

The name of the corporation is BRICK INVESTMENT PROPERTIES CORP. (the "Corporation").

# ARTICLE IV - Registered Office and Agent


