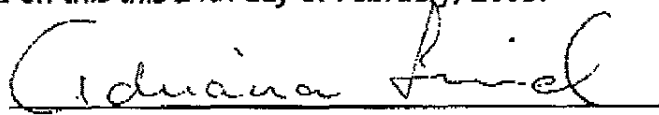
**ARTICLE IX**

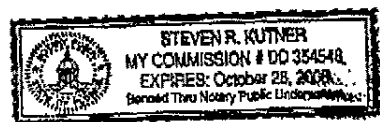

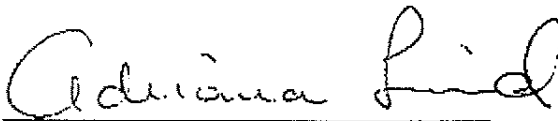
