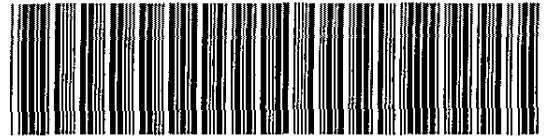

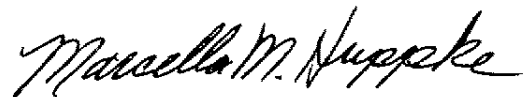

NAME**
