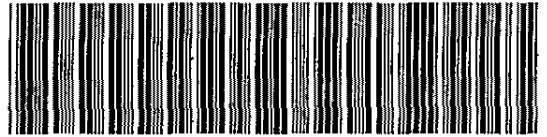



**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

Article I - Name

The name of this corporation is **NEW JEZ ENTERPRISES, INC.**


Article VIII - Indemnification
