

## ARTICLES OF INCORPORATION OF RAD INTERNATIONAL ARCHITECTS, INC

#### ARTICLE I

Name. The name of this corporation is RAD INTERNATIONAL ARCHITECTS, INC.

#### ARTICLE II

Duration. The corporation shall be perpetual.

#### ARTICLE III

<u>Purpose</u>. This corporation is organized for the purpose of transacting any or all lawful business.
