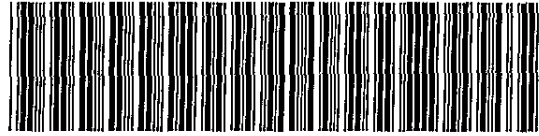

ARTICLE I: NAME

The name of the corporation is: 5JCW., INC.

ARTICLE II: NATURE OF BUSINESS

The nature of the business to be transacted by the corporation shall be:

A. To engage in any activity or business permitted under the laws of the United States and of the State of Florida.

The name and street address of the agent to accept service of process with this State for this corporation are: James C. Williams, 1435 Copenhaver Road, Fort Pierce, FL 34945.


ARTICLE XI: PREEMPTIVE RIGHTS

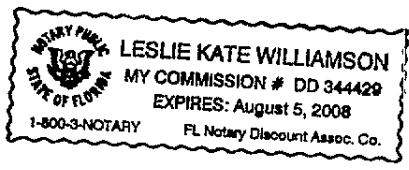


