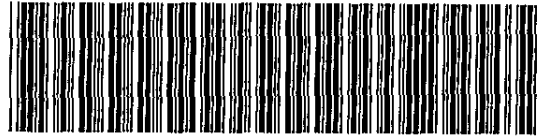



ARTICLE I, NAME

The name of this corporation shall be:

ARTICLE II, NATURE OF BUSINESS

This corporation may be a sub-chapter S corporation as defined by the Internal Revenue Code.





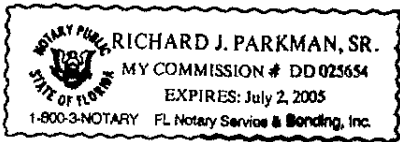
