The undersigned, subscriber to these Articles of Incorporation, hereby presents these Articles for the formation of a corporation under the provisions of Chapter 621, Florida Statutes, also known as The Professional Service Corporation and Limited Liability Company Act, and other laws of the State of Florida.

**ARTICLE I  
NAME**

The name of this Corporation is Broward Mall Dental, P.A.

**ARTICLE II  
NATURE OF BUSINESS**


