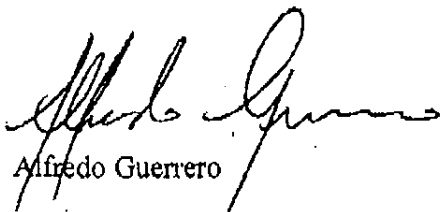
Dear Mr. Guerrero,
