ARTICLES OF INCORPORATION 05 APR -8 PM 4:13

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is ALLISON ADLER, P.A. and its address is ~~1865 North Corporate Lakes Blvd., Suite 1, Weston, Florida 33326.~~ 1500 Weston Rd., Suite 200,

ARTICLE II

Duration

The duration of the corporation shall be perpetual.

ARTICLE III

Purposes

The general purposes for which the corporation is organized are:

(1) To transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act, specifically the business of real estate.

(2) To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

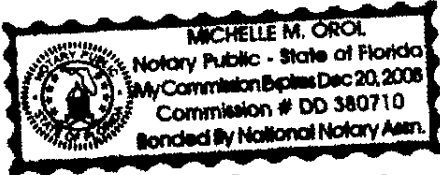
